Membership Category Definitions

- **Consumers:** Any person, professionally unaffiliated with the healthcare industry.
- **Strategic Partner:** Organizations providing strategic leadership and support to MAPS.
- **Health Care System:** An affiliated system of health care providers offering a full range of health care services in different settings and whose operations are managed jointly.
- **Long-term Care Organization:** Any facility, affiliated group or regional chain of long-term care facilities.
- **Provider group:** Any group of licensed health care providers, working together under a single business license.
- **Government agency:** Includes city, county, state, federal government.
- **Non-profit / professional organization:** Trade or professional organizations or organizations with a federal not for profit designation.
- **For-profit Industry:** Any for-profit organization that does not fit in any of the other categories, such as pharmaceutical or IT industry, retail pharmacy chain, device manufacturer.
